DENVER, CO – The Colorado Health Foundation (CHF) recently named Ross Brooks, Adam Schlegel and Michael J. Thomas, Ed.D., as the newest members of its board of directors. Ross Brooks serves as CEO of Mountain Family Health Centers, overseeing the organization's workforce, operations, mission and strategic plan since 2012. Driven by the belief that accessible, affordable health care is a right, not a privilege, Brooks has held multiple leadership roles at health care providers in Washington, D.C. and Colorado and has served on various local, state and national boards and committees, including with the National Association of Community Health Centers and the Colorado Community Health Network.
